- 1. Our common welfare should come first; personal recovery depends on NA unity. What is this group's primary purpose?
 - a. To assist the groups in this area in any way to carry the message to the still suffering addict.
 - i. PI, HI, phoneline, information from other groups...regions, world
 - b. Is this group working together for the common welfare of NA?
 - i. Generally we do a pretty fair job, there are times that it seems we fall short. Probably happens every where else...seems that there is more conflict than necessary...in loving service type mode
 - ii. We do drift and forget what the primary purpose is...especially when money is involved
 - iii. Dawning of a new era...a lot of bodies...make a conscious effort to make this work better than it has.
 - iv. Would like a better way to visualize the information...like the money board.
 - 1. wendy volunteers to write things down
 - v. a suggestions...would like a list of anyone interested to be on the email list...send an email for dances, meetings, special events,
 - 1. howard suggests that judy take over the getting information out to different email addresses...
 - 2. road trips? Making meetings to the out-of- CC meetings
 - 3. subcommittee meetings used to be put on the paper copy of the schedule
 - a. can be done if it is consistent
 - vi. sees a lot of unity. Growing and growing a lot since December. Very loving small group of people. RBS had great accountability. Think too much of RBS and may need to rethink how we see RBS. Disappointed in the lack of literature. Reads from GTLS...responsibility of the groups section...there are no tradition meetings in this area.
 - 1. groups...home group workshops, getting members knowledgeable with home groups
 - v. can ASC travel?
 - a. Group rotation basis
 - b. Need a more central location if we did not rotate
 - c. More groups on meeting nights that have huge groups
 - d. Newsletter?...had an ad hoc for this and no one showed up
 - c. Do member differences get in the way of the group's primary purpose?
 - i. Conflicts with pdap and anchor club events and area meeting...
 - 1. anchor club issue has been solved...with making amends to them and finding proper protocol for using the anchor club
 - 2. a board member is talking about the most recent issue with the anchor club was just a miss communication.
 - d. in what ways could this group improve on "personal recovery" and "unity"?
 - i. listed above...commitment and accountability to this group
 - ii. personal responsibility to area
 - iii. teach new trusted servants, GSR's etc...

- 2. for our group purpose there is but one ultimate authority a loving God as he may express himself in our group conscience. Our leaders are but trusted servants; they do not govern.
 - a. Have this groups decisions been truly an expression of gods will or an extension of powerful personalities?
 - i. Prayer before important issues
 - b. as members of this group, are each of you actively involved in group conscience process or in the stirring up of dissension?
 - i. This is the people who are not involved in this process
 - ii. Get away from the "us" and "them" mentality...with Area and Groups...it is a we program
 - iii. Lack of participation of the gsr's to bring back information
 - 1. training GSR's see #1..d...iii
 - 2. the more groups we have the stronger we become
 - c. are any specific people noteworthy?
 - i. Tom, judy, bea, colin, teresa,
- 3. The only requirement for membership is a desire to stop using.
 - a. Does this group make newcomers feel welcome? How?
 - i. Need to make the new GSR's part of this ... discussion
 - ii. Encourage them to speak up and ask questions
 - iii. Secretary could make sure they have GLS, minutes, agenda, policy, etc.
 - iv. Speak in regular terms...GSR, RCM, TBRCNA, SZF should not be used...
 - v. Someone talked to Kingsville group...wanted to ask questions about things...but because of the inventory...they could not.
 - vi. As a newcomer to this area, she felt that she was shot down many times...this is how we have done it and we will always do it this way...
 - vii. We need to ask...is there anything we can help you with? How many newcomers do you have? Do you want us to visit?
 - b. Is everyone equal in obtaining recovery from addiction at this groups meetings?
 - i. Does not apply at this meeting
 - c. Does anyone attending this group get treated differently if they need a paper signed, mention being sent to the group by a specific enterprise, or don't admit their addicts?
 - i. Does not apply at this meeting.
- 4. each group should be autonomous, except in matters affecting other groups, or na as a whole.
 - a. Does this groups allow outside group members to influence their group decisions and conscience?
 - i. Yes, learns from region...
 - b. Does this groups members try to influence other groups consciences or decisions?
 - i. Do we go to our groups and try to influence them to vote our way.
 - ii. Committee chairs can be influential

- iii. Hear chairs personal opinion
 - 1. solution...go to prayer more often
 - 2. pros and cons...
- 5. each group has but one primary purpose to carry the message to the addict who still suffers.
 - a. Is this group working together as a whole to carry the na message?
 - i. All committees are lacking in participation with 1, 2 or 3 people...with exception to RBS
 - 1. push sponsees to do the 'anonymous' work...pi, phoneline, H&I
 - 2. response to other sub committee reports...do we hoot and holler to all reports or just RBS?
 - b. Do members focus on carrying the message of recovery into the group business meetings?
 - i. Kingsville group was here and asked for sponsors...we did nothing to respond to them.
 - 1. act as a home group to them
 - 2. talk about sponsorship
 - 3. ask, is there anything this group can do to help your group?
 - c. Has any still suffering addict ever been shunned, turned away, or treated differently than a regular member?
- 6. an na group ought never endorse, finance, or lend the na name to any related facility or outside enterprise, lest problems of money, property or prestige divert us from our primary purpose.
 - a. Do any of this groups members endorse any facilities, centers, outside enterprises, etc. while sharing? if so, how are they treated?
 - i. Anchor club...AA...
 - 1. teach by example?
 - b. Is this group separate from any other program that may meet within their location?
 - i. yes
 - c. Do newcomers understand that the na group they attend is not related to whatever location they may be meeting in? how is this done?
 - i. We could mention that we are not affiliated with anchor club...that we mention that we pay rent...that is what the basket is for.
- 7. every na group ought to be fully self-supporting, declining outside contributions.
 - a. Is this group truly self-supporting, declining outside contributions even if its as small an item as coffee or refreshment facilities?
 - b. Does every member in this group do their fair share in supporting this group
 physically as well as financially?
 - i. Yes, fair share is different for all member
 - c. does this group pay a realistic amount of rent to the facility they meet in, or ask for a 'break' because they're not-for-profit?
 - i. We give whatever we gather in the basket...all
 - ii. A suggestion arises about if that is really our fair share.
 - iii. Jimmy reminds us that the unity day event is 25 for under 4 hours; and 50 for over 4 hours

- iv. Judy gives history...this is not a fundraiser, or an na event...they asked for the basket
 - 1. we could pay a minimum of \$25.00 to hold area meetings
- d. Does this group help support other na services region or world? How?
 - i. Policy states that anything above prudent goes to region.
 - ii. Members go to region and serve on committees and hold service positions
- 8. narcotics anonymous should remain forever nonprofessional, but our service centers may employ special workers.
 - a. Have members share about what they consider is a 'professional'

i. pass

- b. Does this group allow professionals special status?
 - i. Not thus far.
- c. Do any professionals who attend meetings share their professional opinion, or their personal stories?
 - i. Yes, 503Cb...matters were handled by judy
 - ii. We have not hired anyone to do this
- d. Does this group utilize any professional service as 'favors'?
 - i. No, not yet

9. na, as such, ought never be organized, but we may create service boards or committees directly responsible to those they serve.

- a. Does this group have a formal chain of command or a unified board of elected trusted servants?
 - i. Yes...
- b. Are this groups committees directly responsible to the group conscience and the na fellowship as a whole? How?
 - i. yes
- c. Do this groups committees have their own management/guidelines/control?
 - i. Yes...all have guidelines...
 - 1. RBS needs guidelines
 - 2. all committee's need guidelines
 - ii. 2 instances where receipts were not needed to be reimbursed...though policy states that a receipt is required for reimbursement.
 - 1. stop overlooking this
- 10. narcotics anonymous has no opinion on outside issues; hence the na name ought never be drawn into public controversy.
 - a. Have any members in this group 'taken sides' in regards to society's problem while sharing?
 - b. Do any of this group members make personal recommendations to hospitals, institutions, religions, beliefs, practices, etc. That could be taken as the groups recommendations?
 - i. Have to be very careful with this issue

- ii. Cannot give out numbers to different treatment centers, etc....
- c. Does this group allow social issues unrelated to na recovery as meeting topics?
 - i. Not applicable
- 11. our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.
 - a. Does this group promote or advertise their na meetings in their local community? How?
 - i. Psa on radio, signage... cc caller;
 - 1. help line number should be put into outlying newspapers
 - ii. Victoria has the schedule in the paper
 - 1. suggestion to put the Victoria phoneline and cc help line in there
 - 2. we need to keep the line of communication open between groups outside of cc
 - b. Does this group have a committee to publicize the groups existence, or does an individual handle the publicity? If by committee, how many group members support this committee?
 - i. Yes, public information
 - ii. 8 committee members
 - c. Does this group appear attractive to newcomers?
 - i. Cut out the crap
 - ii. Fuck the old timers...start with the newcomers
 - iii. Could be of service and contribute something
 - iv. It's interesting and have seen that there is a lot more to na than meetings...claims to be coming back
 - v. What I see is people who like what they have and like what they are doing. True face of America...tattoos, scars, etc.
 - d. Are there any ways that this group could attract more members? How?
 - i. tell sponsees to get involved
 - ii. outreach subcommittee
 - iii. attitude of present area members...gotta be excited about what we are doing...
