# **OLD BUSINESS:**

We realized we had not done roll call again and it began a discussion about voting in the new policy. Samantha had asked about officers having a vote as well as GSRs. Don outlined who is an officer with a voting voice and who gets to or not. We needed to establish a quorum.

Jessica J is requesting \$400 and \$75 for H&I but we will not use the \$75 if H&I does not find a park to host her event.

Jessica J brought up issues that are going on with CBANA with posts that are happening with members that come up periodically. This is why the CBANA page will not host Area business. Troy W clarified this and that it is a CBANA facebook page, not THE CBANA page. Though there are admins who try to keep the peace, we need to be mindful that we can only do the best we can. Don mentioned that other groups have an agreement when you join that you will participate in the group effectively. Paul S comments that the post approval sometimes takes too long or it might be too late. Jake M mentioned adding more admins. Stephen S mentions solutions RBS used, and says if we banned newcomers who are fresh off the streets or out of treatment from CBANA because they don't know how to share...it could keep them from having access to meetings and the information they need. We currently have 8 admins that needs to be updated. Post approval might be the best solution. Megan H asked if a member understands why their post might not be approved and the reasons why. Ed C shares some options for solutions and what he has been currently doing to help facilitate.

Bri M mentioned wanting to puts IPs

Don mentions that NWNA discussed in their group conscience about Facebook and its involvement with CBANA. The group feels we should either take ownership and responsibility of the CBANA page or we can let go of Facebook all together. Megan H asked if we know how other areas are doing things and what they are able to do about the same issues they have been experiencing as well. Troy suggests making Don an admin to help. Don says he will bow out if the other groups do not have a problem. Can we add subcommittee information on CBANA?
