Dear ASC Service Members,

The ad hoc policy subcommittee determined that since the 2017 RBS policy was never voted in by CBANA ASC, it is not valid, despite the last two RBS committees operating under this policy. The ad hoc policy subcommittee will use the original 2013 RBS policy that was voted in by CBANA ASC on April 21, 2013 and revamp this policy to better meet RBS needs.

The ad hoc policy subcommittee is requesting CBANA ASC to formally operate RBS 36 (year 2020) utilizing the 2013 RBS policy. The ad hoc policy subcommittee recognizes the amended clean time requirements for this policy to match the CBANA ASC policy will be five (5) years clean time for all chairpersons handling money.

The members of the ad hoc policy subcommittee have dedicated themselves to meeting monthly moving forward to continue the mission of revising the 2013 RBS policy to better meet the needs of this area and RBS. We have honed down some specific topics and areas of concerns that will be addressed. Additionally, all members agreed that we must add financial guidelines. More will be revealed.
