- The 11th concept establishes the sole absolute priority for the use of NA funds: to carry the message. The importance of that priority calls for total fiscal accountability. Direct contributions to each level of service help us focus on our primary purpose and enhance accountability.
- I'm also submitting a proposal to change policy to have our consensus-based decision-making process format to be read after roll call as it is so that even the newcomer with 30 days clean that starts a new meeting and hasn't read our areas policy will have some understanding of how this area is facilitated. That's Page 6 section c to page 7 of our areas policy. And I also want to discuss the third sentence on section C which states, "this ensures that all opinions, ideas, and concerns are considered in the decision-making process." We are to read this process before reading out reports to have a better understanding of this process, because we're using this process to have consensus on the reports, opinions, ideas, and concerns in this area.

- On 9/29/25, NAWS announced that there will be price increases for literature. The letter can be found here: <https://na.org/wp-content/uploads/2025/09/2026-price-increase-notice-letterhead-2025-09-29.pdf>. The CBANA literature subcommittee has reviewed the 2026 price list provided by NAWS which can be found here: <https://na.org/wp-content/uploads/2025/09/2026-Price-List-2025-09-29.pdf>. The subcommittee has also reviewed each item to determine which ones we will need to charge more for, and which ones will stay the same.
- NAWS is increasing the price of the following items which will result in the need to increase the CBANA price (please note that the *maximum* increase by NAWS is \$5 for *one* of the literature racks & *most* increases are \$1 or less for commonly ordered items):
 - Books: Basic text, It Works How & Why, Just For Today, Sponsorship, Living Clean
 - Service handbooks
 - Group starter kit
 - Literature racks
 - Basic mug
 - Medallions & holders
 - Some rarely ordered specialty items
- CBANA prices for IPs, booklets, key tags, and chips will not change.
- CBANA prices will be increased only where necessary and by the minimum amount necessary to keep the literature bank well-stocked.
- These price changes will go into effect in January, and the Area will be provided with an updated order form in December.

15:16 OPEN FORUM:

- Stephen S. read Area policy, page 20-21, Section V-A
 - 3. CBANA will have two accounts: a savings for prudent reserve and checking for Area operations (current expenditures). It is suggested that both the prudent (savings) as well as the operating (checking) maintain balances of \$2100. Seventh tradition donations from groups will be maintained in the checking/operating account. Funds over \$2100 in the checking account will be voted on to send to Tejas Bluebonnet Region of NA (commonly referred to as region and/or TBRNA). It is suggested that at least 50% of the amount over \$2100 be donated to region. This amount may be raised or lowered depending on the financial status of CBANA (policy change adopted October 2021). A separate account will be established for RBS and Literature. All checks written from the CBANA general fund require a minimum of 2 signatures from trusted servants with check writing authority. Those with authorization are the CBANA Treasurer, CBANA Facilitator, CBANA Co-Facilitator, RCM-1, and RCM-2.
 - 6. All CBANA checking accounts shall require a minimum of 2 signatures on any check.
 - Mario V. - policy was made when we had a different bank and 2 check signers were required.
 - Richard T. – members come in and out and it's been a hassle in the past if there were not enough signers on the account.

- Kimon P. – do what the new bank is asking and just cut up the debit cards that are not needed.
 - Stephen S. – we could go from 4 signers to 3.
 - A proposal needs to be made, and we can table this until next month's meeting when we can make policy changes in January.
 - For now, the bank will accept one check signer so we will move forward for now.
- CBANA voted to host a time slot for the TBRCNA convention held March of 2026 in San Antonio. I was given the honor to head this commitment for our area. I contacted the point of contact in TBRCNA and we chose a time slot.
- Our time slot will be Saturday, March 7th, 2026, from 1pm to 4pm.
